## 2024 Jerry & Roy Lively MONTH LONG Tournament Rules

- 1. Tournament will be for the month of September, commencing September 1, 2024 @ 12:01 AM and ending @ 6:00 PM September 30, 2024. All participants are eligible to fish any day during the month.
- 2. All entries must be submitted prior to fishing. Tournament entry fees will be collected at Dana Landing Market or at the MBMC mailbox.
- 3. All fishing shall be in accordance with IGFA and Club rules; and California and Mexican regulations.
- 4. You must be in the Dana Landing Basin and be visible from the weigh-in dock by 6:00 PM September 30, 2024 with your fish or release slip and documentation for a marlin to count on the last day of the tournament.
- 5. Anglers entered in the tournament may fish on any member's boat that is entered in the tournament.
- 6. Top boat will be decided by the member boat with the most points. One point per pound for weighed in fish. Released fish will count for 150 points. Top angler in Adult and Juniors Division will be decided by the total points for the LARGEST SINGLE FISH SUBMITTED during the tournament. In the case of a tie a random drawing will be held to determine the winner using one chance per submitted fish. Top boat shall be decided by the boat with the LARGEST POINT TOTAL. The species targeted in this tournament is only MARLIN.
- 7. Released Marlin A released fish will be considered captured once a crew member has the leader (not the double line) in hand. THE REQUIRED PHOTOGRAPH OR VIDEO MUST CLEARLY DEPICT THE MARLIN AND HAND(S) GRIPPING LEADER. The crew cannot touch any part of the tackle above the leader until the fish has been officially taken. All conditions of IGFA rules apply to the moment of leadering. Released fish must be verified by DIGITAL CAMERA or SMART PHONE, (see Rule #9 for "Digital Data Documentation requirements). The pictures/videos will be viewed by the tournament committee to verify the catch. The responsibility for providing these proofs of capture rests solely with the fisherman entering the catch. All releases will be reported to MBMC at (INFO@MISSIONBAYMARLINCLUB.ORG) within 48 hours. All digital data will be emailed to MBMC within 72 hrs of the release and by 10:00 a.m. Sunday October 02, 2024. The MBMC release form also needs to be submitted on this timeline.
- 8. Taken Marlin Weighed fish must be verified with a CERTIFIED WEIGH SLIP (<u>the time of actual weigh in must be entered on the slip</u>). A digital photo/video of the certified weigh slip will suffice as evidence. The pictures/videos will be viewed by the tournament committee to verify the catch. The responsibility for providing these proofs of capture rests solely with the fisherman entering the catch. All catches weighed will be reported to MBMC at (INFO@MISSIONBAYMARLINCLUB.ORG) within <u>48 hours</u>. All digital data will be delivered to the MBMC Club Weigh station <u>within 72 hrs of the catch</u> and by 10:00 a.m. Sunday October 02, 2024. The weigh slip documentation also needs to be submitted on this timeline.
- DIGITAL DATA DOCUMENTATION For proof of capture, release, or any other required documentation, digital evidence can be provided <u>only</u> in one of the following ways:
  - a. DIGITAL CAMERA or (SMART) PHONE PICTURE (camera or phone may be requested for in person review).
  - b. DIGITAL (SMART) PHONE VIDEO (phone may be requested for in person review).
  - c. For proof of capture, a <u>picture or video</u> must be taken of the release (clearly depicting the marlin and hand(s) gripping leader). Video and/or picture files will be submitted to <u>info@missionbaymarlinclub.org</u>

- All catches, released or weighed will be reported to MBMC at (INFO@MISSIONBAYMARLINCLUB.ORG) within <u>48 hours</u>. Digital documentation, weigh slips, & release forms will be emailed to MBMC <u>within 72 hrs.</u> of the catch and by 10:00 a.m. Sunday, October 02, 2024.
- 11. <u>All fish, weighed or released, that are presented to another weigh station must be reported to MBMC at (INFO@MISSIONBAYMARLIN.ORG) by 8:00 p.m. the day of fishing.</u> Any boat with a qualifying billfiish catch or release must be at the Mission Bay Marlin Club or any other recognized certified weigh station the day of fishing and by 8:00 pm Friday, September 30, 2024. If not at the Mission Bay Marlin Club dock, then a photograph/video of the Team Members in front of the Certified Weigh Station. Followed by a photograph/video of the boat's GPS showing the time at or before 8:00 pm Friday, September 30, 2024.
- 12. Boat Scoring: 4 points for first place, 3 for second, 2 for third, and 1 for Entry (if not in top 3). These points accumulate for all MBMC tournaments open to all members for the angling year 2024. The boat with the most points at the end of the year will be awarded the Top Boat.
- 13. All protests must be received in writing no later than 24 hours after final weigh-in and will be reviewed by the Protest Committee for validity.
- 14. Payouts will be 100% of entries for both Adult and Junior Divisions will be 100% of their entries. Top Boat is a year-end award and there will be no pay out.
- 15. If there is a Division Tie, those Anglers will be entered into a drawing for the Prize.
