Mission Bay Marlin Club - Release of Liability

- 1. All club members and any guest(s) participating in club sanctioned events shall hereby release Mission Bay Marlin Club from any liability for injuries to self or property sustained as a result of said events. Upon signing below, any member or participating guest hereby releases, waives and discharges the Mission Bay Marlin Club along with its board of directors, agents, employees, independent contractors, and affiliated organizations from any claim, liability, or demand of any kind or on account of any personal injury, temporary or permanent disability, death, property damage, or other damages, whether caused by the negligence or otherwise, resulting from or in any way associated with Mission Bay Marlin Club members or their participating guest's entry on the Mission Bay Marlin Club's premises, receipt of services, or participation in any of the activities or tournaments hosted by the Mission Bay Marlin Club. This release and waiver of liability applies to both club premises and any outside location where club events or activities are held to include but not limited to time spent on the water while participating in club sanctioned fishing events.
- 2. As a Mission Bay Marlin Club member in good standing, as well as any guest of said member, it is understood that you will hereby voluntarily assume all risk of personal injury, including temporary or permanent disability or death, property damage, economic losses, and/or other damages to any member or participating guest resulting from or in any way associated with his/her entry on the Mission Bay Marlin Clubs premises or participation in any of the tournaments or activities at the Mission Bay Marlin Club whether on the premises or not.

As a member or participating guest, you hereby acknowledge and agree that this release and waiver of liability, along with assumption of risk agreement is intended to be, and is upon your signature, a complete release of any responsibility of the aforementioned Mission Bay Marlin Club board members and affiliates for personal injuries and/or temporary or permanent disability or death and/or property loss/damage sustained by club member or participating guest while on the Mission Bay Marlin Club's premises or while participating in any of the activities or tournaments at the Mission Bay Marlin Club whether on the premises or not.

As a Mission Bay Marlin Club member or participating guest, you hereby grant the Mission Bay Marlin Club, and those acting on behalf of the Mission Bay Marlin Club with authority and permission, the irrevocable and unrestricted right and permission to use and publish photographic portraits or pictures of members and their participating guests for historic purposes and club promotion.
